

The Mint Leasing Guidelines

No Minimum BEACON SCORE, Income must be as stated.

Multiple Open Autos - OK

DRIVER'S LICENSE – All applicants must have a VALID and IN STATE Driver's License.

Co-signer without DL will be considered if they are not the driver of the car and the situation is approved at time of application. Driving records will be checked and deals with outstanding traffic warrants or suspended or revoked licenses will not be funded.

CO-BUYERS – Co buyers or co-signers are allowed but they must live at the same residence.

STABILITY – Minimum 4 months job and residence time to be considered. Require 5 year employment and residence history. Customer must be on lease or mortgage. (Will consider applicants living with family on a case by case basis.)

CIVIL JUDGMENTS AND TAX LIENS – OK

REPOSSESSIONS – Will consider multiple repossessions if the deficiency balance is paid or if customer has re-established current credit.

BANKRUPTCY – Open Chapter 13 OK with letter from the trustee. Multiple BK's OK. Dismissed BK's OK.

SELF EMPLOYED – Self Employed Applicants OK. Bank statements or tax returns required to verify income.

MILITARY– E4 or higher applicants only. No Power of Attorney signings for deployed military personnel.
